SUPERINTENDENT'S MESSAGE

In developing the budget for the 2014-2015 school year, our District was faced with the now familiar pattern of steep challenges and difficult decisions. As has been our practice, the Board of Education maintained a primary focus of balancing the needs of our children with the ability of taxpayers to support those needs. There were, however, some differences that factored into the completion of this year's spending plan.

First, the fiscal pressure in the form of the Gap Elimination Adjustment, although still intense, lessened to a degree with the passage of the final State budget. Newark Valley Schools will still have \$1,122,293 of aid withheld through the GEA this year, and although it is a painfully large amount, it is less than was initially projected in the Governor's budget.

Second, New York State has adopted a tax rebate plan for STAR eligible property owners for the 2014-2015 budget year. The operational guidance from the Department of Taxation and Finance is as follows:

A STAR eligible property owner (household income of less than \$500,000), in a school district that remains at or below their allowable levy limit, will receive a check from the Department of Taxation and Finance for the dollar increase in their school tax bill in the fall of 2014. For example, if a homeowner had a \$1,000 tax bill in 2013-2014, and that tax bill increased by 2% in 2014-2015, their dollar increase would be \$20. In the fall of 2014, they will receive a check from NYS in the amount of \$20, effectively providing them with a 0% increase in their school tax bill. This formula holds true regardless of the increase, as long as the school district remains at or below their allowable levy limit. The one exception to this is that there is a floor of 1.46%. In other words, eligible property owners will receive a refund check for the greater of the increase in their school tax bill or 1.46%. Additionally, increases due to owner action and subsequent re-assessment, (home additions, new buildings on a property), are not covered.

The Newark Valley Central School District has adopted a budget below the allowable levy limit for the 2014-2015 school year, qualifying our residents for the above tax credit. After several months of work, the Board adopted a budget that increases expenditures by approximately 2.8% and results in a necessary tax levy increase of 2.4%. As in past years, we continued to pursue a balanced approach to budgeting, and manage cost reduction in a fashion that did not impact program.

This budget reflects a number of internal adjustments to maximize our program offerings and best meet the needs of our students. Although we will be reducing 1 support staff position (through attrition), and 2.5 faculty positions (2 through attrition) in certain areas, we will also be rebuilding or expanding in others. Our budget includes the maintenance and expansion of our career transition program at the High School, the maintenance of academic support services for our elementary students, the reinstatement of department and grade level chairs, replacement of the High School Assistant Principal at reduced hours, expanded online course offerings for our High School students, the addition of Advanced Placement U.S. History, the restoration of a maintenance mechanic, and the restoration of a Guidance Counselor (.6) at the High School.

In sum, the Board has adopted a budget that not only maintains modest and conservative growth, but focuses on maximizing the expansion of opportunities for our students in the most efficient manner. We continue work very hard in meeting the challenges that arise, and always do our best to minimize the impact of these circumstances on both students and taxpayers.

Propositions on the Ballot

Proposition #1 Vehicle Purchase

Shall the Board of Education of the Newark Valley Central School District, located in the counties of Tioga, Tompkins, Cortland and Broome, State of New York, be authorized to finance the costs of the acquisition of school buses and a passenger vehicle at a maximum cost of \$360,000 and to authorize and issue serial bonds in the principal amount of \$360,000 and to levy real estate taxes for the cost of such purpose?

Proposition #2

Shall the Board of Education of the Newark Valley Central School District, located in the counties of Tioga, Tompkins, Cortland and Broome, State of New York, be authorized to expend \$40,000 from moneys in a capital reserve fund established by the School District on May 12, 1993, as amended on May 21, 2002, for the purchase of School District vehicles, including school buses and any other preliminary and incidental costs related thereto in and for the School District?

<u>Proposition #3</u> Facilities Improvement

Shall the Board of Education of the Newark Valley Central School District be authorized to expend from the reserve fund approved by the voters of the school district on May 11,1994 under the provisions of Education Law 3651 and as amended by the voters of the district on May 15, 2007, an amount not to exceed \$100,000 for the following purposes at Newark Valley Central School District Bus Garage: Removal and closure of the exist-ing underground fuel storage tank and providing new fuel tank including all appurtenances, and other allied expenses including architectural and engineering fees, and legal fees?
