Presentation: Mrs. Katchuk reviewed the Comparative Budget Data, Reserve Funds and Debt Service of the proposed 2015-2016 Budget.

Superintendent's Report: Superintendent Dougherty provided a brief State Aid Analysis based on the Governor's Executive Proposal – 1.4% increase in foundation aid, 2.2% decrease in building aid and a 3.3% increase in expense-based aid. Discussion followed. Also, Mr. Dougherty spoke of the recent Legislative Breakfast Meeting. Some subjects discussed were the Senate wanting full GEA restoration, the Assembly being focused on foundation aid, mandate relief, Federal Government withholding Title I money if "opting out" continues. Discussion followed. Additionally, Senator. Akshar will be visiting NVCSD on 2/26/16 to learn more about our district. Snap-shots of Success: Superintendent Dougherty commented how co-workers pulled together when a staff member experienced a house fire with many donations made. Additionally, Newark Valley CSD was well represented at the recent Legislative Breakfast Meeting.

Instruction: Elementary School-Robert Rodgers, Principal: Students recently participated in the Annual Sharing Parade; approximately 100 students participated in the 4th Annual Festival of Learning where students create a project and present their projects to staff, students, family and the community. Mr. Rodgers also spoke of Nathan T. Hall's Listening and Learning Program (30-45 minutes of reading aloud covering topics in math, science and social studies). Discussion followed.

High School-Michelle Bombard, Principal: AP Biology, Photography and Electronics students recently participated in the MS STEM night; the Newspaper Club is in the early stages of working on a news broadcast; coat and denim drives were recently hosted by students for Tioga County shelters; Thomas Shofkom and Kaya Luciani recently performed at NYSSMA Area All State; February 19th and 20th is The Wiz musical; NYS recently released graduation rates -- NVHS has increased to over 90%; the YES Club coordinator and 10 club participants have begun touring colleges; 21 sophomores will be visiting the Career and Tech Education programs at BOCES; and the annual floor hockey tournament begins on 2/9/16. Discussion followed. Additionally, several HS wrestlers will be attending sectionals this upcoming weekend at the Binghamton Arena and the IAC Cheerleading Competitions were recently hosted at the HS – NV Cheerleaders are the new IAC Large School Champions.
