The Newark Valley Central School District Board of Education met at 7:00 p.m. in the Richard H. Kerr Board Room. <u>Presentation:</u> Mrs. Katchuk provided an overview of the First Draft of the General Fund Budget. Discussion followed regarding the increased dollar amount of BOCES' Special Education services as well as the next steps for the District's budget.

**Privilege of the Floor:** Robin Shaver, NVCSD Bus Driver, spoke of disciplinary actions of unruly students in the classroom versus disciplinary actions of unruly students on buses as well as the process in which those students are reported. Additionally, Ms. Shaver spoke of the need to have the appropriate/necessary cleaning supplies for bus clean-ups.

Superintendent's Report: Todd Schaffer, Middle School Principal, summarized highlights at the Middle School. Discussion followed on Girls' Grade 7 Basketball went undefeated this year; Benny Baker (Grade 7) went to States' for wrestling; MS students participated in Architectural Awareness (turning the old Ladder Factory into a tech center); three teams went to Odyssey of the Minds at BOCES; and the After School Program, which is open to all students at any time during the school year.

Superintendent Dougherty recently attended the NYSCOSS' Winter Conference. Discussion followed on the various lectures (Commissioner's address) and workshops (blended learning) he attended as well as the State Budget.

Snap Shots of Success: Superintendent Dougherty recently attended Morning Program where Mrs. Kaufman's 3<sup>rd</sup> Grade class wrote and delivered the fun things that can be done in the winter. Several 8<sup>th</sup> graders recently spent the day at Lockheed Martin for Engineering Day. Mr. Phillips mentioned that those wrestlers who went to States represented the District well. Mr. Parmelee inquired about the Veteran's Exemption Tax and what the impact would be on the District. Requested that it be analyzed so the District could make an informed decision should the time come.
