Snap-shots of Success: Superintendent Dougherty congratulated the Scholarship Challenge participants who will be at finals in Sayre, PA during the week of March 21, 2016.

Instruction: Elementary School-Robert Rodgers, Principal: Mr. Rodgers reported on Nathan T. Hall's focused agenda items for the recent Superintendent's Conference Day. Mr. Rodgers also provided an update to the Listening and Learning Program (interactive read aloud for K-2). Discussion followed.

High School-Michelle Bombard, Principal: Mrs. Bombard reported: Grade 8 students recently attended Lockheed Martin's Engineers Day; spring sports started March 7 with approximately 40% of HS students participating; 42% of HS students participated in All County Band and Chorus, contemporary Music Night and the Annual Prism Concert; art students recently toured Cornell's Johnson Museum of Art; Alissa Goodrich's painting was on display with discussion on a full tuition scholarship at College for Creative Studies in Detroit; and the 10-period bell schedule was discussed. Discussion followed on the July 2016 Group Work Camp coming to Tioga County and being housed at the high school. This is an organization that provides one week mission trips for youth who provide hands-on repair projects to low-income, elderly and disabled homeowners at no cost to the homeowner.
