# NEWARK VALLEY CENTRAL SCHOOL DISTRICT BOARD OF EDUCATION MEETING MINUTES

March 23, 2015

The Newark Valley Central School District Board of Education met at 7:01 p.m. at the High School Café, in the Lower Level Library. The following Board Members were in attendance: Randal H. Kerr, James Phillips, Thomas Darpino, Ralph Parmelee, Susan Watson, Anthony Tavelli and Robert Bennett. The Pledge of Allegiance was led by James Phillips. The following school personnel were present: Ryan Dougherty, Ji Katchuk, Michelle Bombard, Warren Harrold, Ed Mertson, Gary Hoskins, Debra Demers, Mary McCloe, Phyllis Kaufman, Erin Wilday, Keith Williams, Bryan Yurka, Michelle Tavelli, Patti Engbith and Tina Engelhard. There were 56 guests.

Presentation: Mrs. Demers thanked everyone who had attended the grand opening of the Café. Mrs. Demers acknowledged and introduced Brenda Smith, Grant Committee Chairperson-Floyd Hooker Foundation who spoke a few words. As noted, without the grant the HS Café would not have been possible. Mrs. Demers introduced and thanked the Café Committee, Michael Cucci for his architectural designs, Gary Hoskins and Buildings & Grounds for their unwavering work and support, the creative works from the Technology and Art students, commitment of the student staff as well as the Board of Education for their approval of the project. Mrs. Demers explained the correlation between the various educational courses and the individual jobs the students have within the Café. Discussion followed on daily operations, menu items, credit hours, etc.

Fred Riordan, from the Riordan Group, provided an extensive and in-depth update on the capital project (transportation facility and EXCEL). Discussions followed.

Mrs. Katchuk provided a detailed review of the Administrative, Capital and Program Components for the first draft of the 2015-2016 Budget. Discussions followed on changes, 5-year trend, etc.

Superintendent's Report: Superintendent Dougherty said a few words on the NYSCOSS Winter Institute conference he recently attended. It was agreed upon by conference attendees that Albany is in a state of chaos. Mr. Dougherty stated that this year's state aid will most likely fall between \$1.3-\$1.5B. Discussions followed. Michelle Bombard, HS Principal, addressed the Board regarding the future of the foreign language programs at the HS. Currently, there are 72 students enrolled in the German program. Mrs. Bombard stated that with Mr. Mischke retiring, the HS will need to hire a 0.5 FTE German Teacher in order to provide 64 of those 72 students the ability to finish their sequence. Discussions followed on scouting for a German teacher and exploring for a different foreign language program. Snapshots of Success: Superintendent Dougherty spoke of the Scholarship Challenge over the weekend in Sayre, PA. Newark Valley's team competed against 26 other teams and placed 2nd overall, winning a \$1500 scholarship. Also over the weekend, Odyssey of the Mind was runner up and Mathalon also competed.
