Superintendent's Report: District Updates: Superintendent Calice spoke on the New York State Blue Ribbon Commission graduation requirements and the top 5 of 12 recommendations: 1) one diploma; 2) ensure access to career and technical education (CTE), including internships and work-based learning opportunities; 3) reduce and/or modify diploma assessment requirements to allow more assessment options; 4) create more specific, tailored graduation requirements to address the unique circumstances of certain groups of students (i.e., non-compulsory age students, newcomer students, refugee students), 5) provide exemptions from diploma assessment requirements for students with significant cognitive disabilities and major life events and extenuating circumstances (i.e., medical conditions, death of a family member, trauma prior to sitting for a required exam). Snapshots of Success: Superintendent Calice congratulated the National Honor Society-23 students with 4 new inductees. Mr. Mertson stated: Cha Gardner has signed to play basketball at Stephen F. Austin University; Harley Switzer recently competed at NYSPHSAA Cross Country Championships placing 26th out of 111 student athletes; and winter sports started today. Mr. Asfoury stated the Engineering Program has 15 students from Grades 6 and 7 participating. Mr. Rodgers stated there will be parent-teacher conferences this week and are shooting for 100% participation.

Instruction: Valerie Murtha, Director of Data and Instructional Progress presented the 2022-2023 State Assessment Data regarding Grades 3-8 ELA scores, Grades 3-8 Math scores, trend reports, gap analysis, current data work and next steps, Regents results, comparisons to Broome-Tioga BOCES and SCRIC, adjustments and finances.
