Superintendent's Report: \$100k Project: Superintendent Dougherty recently met with Gary Hoskins, Director of Facilities, to review the project. The 2020-2021 project will cover the camera upgrade throughout the Middle School and camera wiring at Nathan T. Hall Elementary entrances. Superintendent Dougherty reminded the Board that the \$100k Project is fully reimbursable the school year following the completion of work. Discussions followed. Coronavirus Update: Superintendent Dougherty stated that he had had multiple conversations with neighboring county public health departments as well as Tioga County Public Health and NYS Department of Health starting Friday and continuing through Sunday. NYSDOH and Tioga County Public Health requested and recommended a pause for the District from October 26 through November 6, 2020. The two (2) weeks of being fully remote would allow those staff and students who had been and those who need to be quarantined to return on November 9, 2020. As some students are struggling with remote learning, parents are urged to contact the appropriate building principal for assistance so their student does not fall behind. Brief discussions followed on the Superintendent's community letter, impact of quarantine/remote learning, contact tracing, increasing rates in the region, preparing staff about holiday plans and numbers going into the winter months. Snapshots of Success: Superintendent Dougherty thanked all parents for being able to pivot to full remote learning. He knows that it has not been easy and appreciates each of them. Mr. Schaffer commented that Grades 4, 5 and 6 went remote for the first time today and shared that it was as good a day as it could be. Additionally, Mr. Schaffer stated that being a remote teacher has been more difficult than teaching students face-to-face, yet he knows this will make them better teachers and learners. Superintendent Dougherty commended Jennifer Hoover for her unbelieve job performance as the HS Nurse, District's Lead Nurse and COVID Liaison. Ms. Hoover stays in constant contact with Superintendent Dougherty and Tioga County Public Health. Discussions followed.
