Superintendent's Report:

Superintendent Dougherty started by thanking teachers, aides, bus drivers and staff in getting the students of our district home safely on September 7th. Additionally, he thanked Gary Hoskins and his staff (especially Jim Olmstead), who did a tremendous job during the flood by working 5 days straight 24 hours a day in order to make it possible to have school re-open on Monday, September 12th. Mr. Dougherty spoke on the non-mechanical flooding items (i.e., meeting with the insurance carrier, contacting of FEMA, conditions of the playing fields and what the next step will be). Gary Hoskins spoke on the mechanical issues caused by the flooding (i.e., drainage, water pumps, electrical, transformer, geo thermal, elevators, boilers and heat pumps). Additionally, Mr. Hoskins noted that Jim Drew, TST BOCES Health & Safety Coordinator, and Tioga County Health Department had been to the District and deemed the buildings were safe to return to. Snapshots of Success: Superintendent Dougherty thanked the Berkshire Fire Department for their immediate and continued response to the District during the flooding, as well as the assistance from the Richford, Newark Valley and Weltonville fire departments.
